## Dementia Friends Training - Tasha Howard & Bridget Morrisroe

- Defined Dementia:
  - Dementia is not a specific disease. It is an overall term that describes a wide range of symptoms associated with a decline in memory or other thinking skills severe enough to reduce a person's ability to perform everyday activities.
- Shared a table comparing normal aging vs. Alzheimer's Disease symptoms.
- Read the 'Bookcase Story' which compares a healthy brain vs. a brain as Dementia progresses.
- Touched on communications strategies for interacting with people with Dementia:
  - Treat the person with dignity and respect.
  - Be aware of your feelings and tone of voice.
  - Be patient and supportive.
  - Offer comfort and reassurance.
  - Avoid criticizing or correcting.

- Avoid arguing.
- Offer a guess if the person is using the wrong word or cannot find a word.
- Encourage nonverbal communication.
- Shared Dementia Caregiver Resources.
