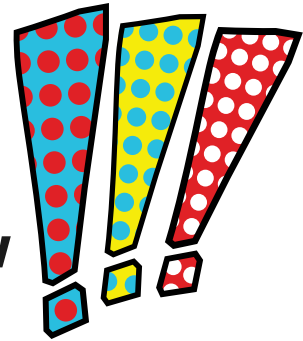

August 21, 2026

Feel free to include a statement explaining your art.

Entries must be original and unpublished.

We reserve the right of first publication and use of all writings and drawings. All entries may be published in a 2026 book called "My Family. My Story." that will be posted online at 211.idaho.gov, distributed within the Idaho Department of Health and Welfare and to participants
